Commissioner Boyle reported that she met with Tim Brown, the Director of Innovation and Strategy, at Northeast Arc regarding the possibility of a project similar to one that another human services agency runs in collaboration with the Newton Housing Authority. When complete, the project would comprise two 2-bedroom units at the Parkview, plus a duplex, leased to a human services agency, which would undertake tenant selection and provide weekly on-site case management. Individual tenants could receive drop in services through Group Adult Foster Care, and, as appropriate, through the Department of Developmental Services. The project would be undertaken in stages, one unit at a time. A follow up meeting is planned. An appropriate starting point would be to have Tim Brown participate with the WHA in a presentation of the concept to the Select Board, including the reasoning for proceeding one unit at a time, and the advantages of having all four units on board.
